## Bylaw No. 7/2005

## A BYLAW OF THE VILLAGE OF ST. BRIEUX TO REGULATE & CONTROL THE POSSESSION OF DOGS WITHIN THE VILLAGE.

A Bylaw pursuant to Section 135 of *The Urban Municipality Act, 1984*, to prohibit Pit Bull Terriers, Rotweilers, German Shepherds and Doberman Pinchers in the Village of St. Brieux.

The Council for the Village of St. Brieux, in the Province of Saskatchewan, enacts as follows:

- 1. In this Bylaw:
  - (a) "Owner" includes:
    - i) A person who keeps, possesses or harbors a restricted dog;
    - ii) The person responsible for the custody of a minor where the minor is the owner of a restricted dog;

but does not include:

- iii) a veterinarian registered pursuant to *The Veterinarian Act, 1987*, who is keeping or harboring a restricted dog for the prevention, diagnosis or treatment of a disease of or an injury to a restricted dog,
- iv) an Urban Municipality or the Saskatchewan Society for the Prevention of Cruelty to Animals in respect of an animal shelter or impoundment facility operated by it.
- (b) "restricted dog" means any dog, whatever its age, male or female, of the following breeds or kinds:
  - i) Pit Bull Terrier;
  - ii) American Pit Bull Terrier;
  - iii) Pit Bull;
  - iv) Rottweiler;
  - v) German Shepherd or;
  - vi) Doberman Pinscher
  - vii) any combination or portion of the breeds mentioned in subclause 1(b)(i) to 1(b)(vi) inclusive
- 2. No owner shall keep, possess or harbour a restricted dog within the boundaries of the Village of St. Brieux.
- 3. Any owner who keeps, possesses or harbours a restricted dog within the boundaries of the Village of St. Brieux, is guilty of an offence and liable on summary conviction to a fine not exceeding \$2000.00 and in default of the fine, to imprisonment for a term of not less than 7 days, nor more that 30 days, unless the fine is sooner paid.

- 4. In the case of a conviction under the provisions of the Bylaw, the convicting justice shall order the convicted owner to cause the restricted dog, within 10 days of the date of the order, to be removed from within the boundaries of the Village of St. Brieux.
- 5. This Bylaw shall come into force and take effect on the day of final passing thereof.
